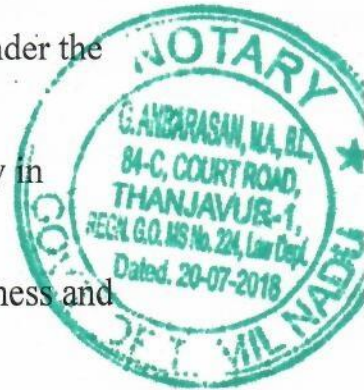

6. That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.

7. That the Principal and Correspondent of the school have individually gone through the provisions contained in the affiliation & examination byelaws and circulars issued by the Board from time to time.
